In Home

- Services designed to keep children within their homes or supportive services provided to the child or child's family while the child is in substitute care.
- Types of services include:
 - Adoption Services/Adoption Assistance
 - Counseling and Intervention
 - Day Care
 - Day Treatment
 - Homemaker/Caretaker Services
 - Life Skills
 - High Fidelity Wrap around

Community Based Placement

- Substitute care services in a facility that serves no more that 25 children and uses community resources in its program of service.
- Types of care include:
 - Kinship care
 - Foster care
 - Group Home care
 - Supervised Independent Living
 - Shelter care

Institutional Placements


- Substitute care service in a secure or non-secure facility that is not community based.
- Types of care include:
 - Juvenile Detention Services
 - Residential treatment facilities
 - Secure facilities
 - Youth Development Centers
 - Youth Forestry Camps

Administration

- Expenses associated with the agency operational costs including activities to manage a county children and youth social service agency.
- Operational costs include:
 - Rent and Utility costs
 - Communication expenses
 - Transportation expenses
 - Supplies

Family Group Decision Making

- Strengths-based initiative
- Family members are active participants
- Implemented in 2005 by Lehigh County
- Additional training in progress for staff in order to expand the process

Family Credentialing

- Train the trainer initiative
 - Provides OCYS line staff and provider staff with additional skills to facilitate relationships with clients
- Engaged in expanding OCYS staff participation



First Tier Participant: Roll Out of PA Permanency Practice Initiative

Family Finding

- Engaged in staff training to find and gather family members.
- Designated a staff member to serve as the Diligent Search Person.

National Governor's Association Out of Home Placement Reduction one of 14 Counties in PA.

- Safely reducing out of home placement by 20% before the end of 2010.
- Decrease utilization of institutional placement
- Decrease utilization of secure institutional
 - Liberty-Lehigh Secure Treatment for Adolescents

Juvenile Probation Initiatives

- ❖ Youth Level of Service- Risk Need Assessment-Internal tool to help better identify risks and needs in offenders so as to appropriately funnel them into the best services.
- Case Management Essentials development of case specific supervision plan based on risk and need.
- Expansion and improvement of Aftercare services for youth returning from placement.
