A public hearing on the 1987-1991 Capital Plan was held this date in the Commissioners' Hearing Room, Courthouse, with Commissioner John W. Brosious, Chairman of the Planning Committee presiding.

Members present were: Commissioners Brosious (Chairman), Baker, Mohr and Wieand (late). Also present were Commissioners Eisenhard and Raber, Mary Haney, John Kachmar, Jim Creedon, Gordon Roberts and members of the Press.

Commissioner Brosious announced that he would review each project of the Capital Plan as presented by the Administration, then the changes to it as a result of the formulation of the Bond Issue Project List at the Special Meeting on July 30. He indicated that he would entertain recommendations at any point in the process. The following is not necessarily in the order of occurrence but summarizes the proceedings:

John Kachmar, in response to Commissioner Baker's concern about the continual expansion of the County's computer expansion, indicated that the computer projects identified in this Capital Plan are for the Judiciary and are essential to the smooth functioning of that branch of government. Commissioner Mohr suggested that because the Plan is for five (5) years, there is flexibility as far as the scheduling of various units. Drum King added that he would not recommend changing the amount of this project before the closing on the bond issue as this would affect its sizing. After that date, he indicated that, as legislators, the Board has the prerogative to amend the Capital Plan as it wishes.

On a motion by Commissioner Baker and seconded by Commissioner Brosious the Planning Committee voted 2-1 (with Commissioner Mohr dissenting) to recommend deletion of this project. Commissioner Mohr then made a motion which died for lack of a second to recommend retention of the project at \$400,000 but to re-name it "Alternative Office Space". The rationale for his action, he explained, is the need to recognize that the County may have to acquire additional office space in the future and that good planning dictates making provision for it beforehand. Given information, subsequently

by Jim Creedon and Drum King that the recommendation for deletion of the project would jeopardize the bond issue for the same reasons given for the Computer Expansion/Upgrade project, the Committee decided to join in with Commissioner Mohr's recommendation. Commissioner Mohr then made the motion again which was seconded by Commissioner Baker, to recommend replacing the Colonial Theatre project with Office Acquisition/Renovation at \$400,000 with a 1987-1991 timeframe. The vote was 4-0 in favor. (Commissioner Wieand arrived at this point.) The Committee was assured by Attorney King and John White that this rewording was appropriate in that it would not affect the bond issue ordinance but only "Exhibit A", the list of projects on which the bond issue is based.
