WHEREAS, due to unforeseen delays, one of the recipient organizations has requested an extension of time beyond the two (2) year period (until September 14, 2015) to complete the project:

WHEREAS, ordinance approval is required to extend the time for the grant to Salisbury Township.

NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF LEHIGH, PENNSYLVANIA, THAT:

- 1. The foregoing WHEREAS clauses are incorporated herein as if set forth in their entirety.
- 2. The extension for Salisbury Township, as set forth herein, is hereby approved. Disbursal of the funds shall be contingent upon execution of grant agreement.
- 3. The proper officers and other personnel of Lehigh County are hereby authorized and empowered to take all such further action, including any necessary transfers of funds, and execute additional documents as they may deem appropriate to carry out the purpose of this Ordinance.
- 4. Any Ordinance or part of any Ordinance conflicting with the provisions of this Ordinance is hereby repealed insofar as the same affects this Ordinance.
 - 5. This Ordinance shall become effective in ten (10) days after enactment.
