**APPROVING A DONATION TO CRIME VICTIMS' COUNCIL FROM  
JUVENILE PROBATION'S GOLF TOURNAMENT FOR 2015**

---

**WHEREAS**, Juvenile Probation sponsors an annual golf tournament with a goal of raising money to help compensate victims of delinquent offenses not compensated by court-ordered restitution; and

**WHEREAS**, the money collected from the tournament this year totaled \$6,914.60 and is deposited in line item 100302.000.46534; and

**WHEREAS**, Juvenile Probation wishes to donate the funds to the Crime Victims' Council of the Lehigh Valley for distribution to crime victims who meet certain hardship criteria; and

**WHEREAS**, Ordinance approval is required for grants made outside of the budget process pursuant to the Lehigh County grants policy.

**NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED BY  
THE BOARD OF COMMISSIONERS OF THE COUNTY OF LEHIGH,  
PENNSYLVANIA, THAT:**

1. The foregoing WHEREAS clauses are incorporated herein as if set forth in their entirety.

2. The donation from Juvenile Probation of \$6,914.60 to the Crime Victims' Council of the Lehigh Valley is hereby authorized.

3. The proper officers and other personnel of Lehigh County are hereby authorized and empowered to take all such further action, including any necessary transfers of funds, and execute additional documents as they may deem appropriate to carry out the purpose of this Ordinance.

4. The County Executive shall distribute copies of this Ordinance to the proper officers and other personnel of Lehigh County whose further action is required to achieve the purpose of this Ordinance.

5. Any Ordinance or part of any Ordinance conflicting with the provision of this Ordinance is hereby repealed insofar as the same affects this Ordinance.

6. This Ordinance shall become effective in ten (10) days after enactment.
