ORDINANCE NO. 2016 -**

**AUTHORIZING THE COUNTY EXECUTIVE TO TRANSFER FUNDS FROM
THE STABILIZATION FUND TO THE OFFICE OF THE CORONER TO FUND
A FULL-TIME DEPUTY CORONER**

WHEREAS, by Ordinance 1979- No.111, the Board of Commissioners of Lehigh County enacted a complete Job Classification Plan; and

WHEREAS, by Ordinance 1979- No. 122, the Board of Commissioners enacted a complete Pay Plan; and

WHEREAS, by subsequent Ordinances the Board of Commissioners has amended the aforesaid plans to meet the changing personnel needs of the County; and

WHEREAS, budget Ordinance 2015-129 added a new position of Deputy Coroner, however the position was funded at \$1; and

WHEREAS, at the request of the Office of the Coroner and the Department of Administration, the Director of Administration has proposed the transfer of \$46,259 from the Stabilization Ending Fund Balance to the budget of the Coroner to fund the position of the new Deputy Coroner; and

WHEREAS, ordinance approval is required to amend the 2016 budget and to transfer funds from the Stabilization Fund, pursuant to section 706 of the Home Rule Charter and Ordinance No. 2003-168.

**NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED BY
THE BOARD OF COMMISSIONERS OF THE COUNTY OF LEHIGH,
PENNSYLVANIA, THAT:**

1. The foregoing WHEREAS clauses are incorporated herein as if set forth in their entirety.
2. The County Executive is hereby authorized to move the sum of \$46,259 from line item 1142.151300.29912 Stabilization Ending Fund Balance to line item 1101.010300.41111 Full-Time Employees. This transfer shall occur immediately.
3. The proper officers and other personnel of Lehigh County are hereby authorized and empowered to take all such further action, including any necessary transfers of funds, and execute additional documents as they may deem appropriate to carry out the purpose of this Ordinance.
4. The County Executive shall distribute copies of this Ordinance to the proper officers and other personnel of Lehigh County whose further action is required to achieve the purpose of this Ordinance.
5. Any Ordinance or part of any Ordinance conflicting with the provisions of this Ordinance is hereby released insofar as the same affects this Ordinance.
6. This Ordinance shall become effective in ten (10) days after enactment.
