WITHDRAWING FROM THE JOINT-COUNTY DEPARTMENT OF HEALTH AND REPEALING THE COUNTY'S AUTHORIZATION TO FORM A SINGLE COUNTY DEPARTMENT OF HEALTH

WHEREAS, by Ordinance 2007 - No. 227 the Board of Commissioners authorized the establishment of a Joint-County Health Department with Northampton County; and

WHEREAS, pursuant to Section 5.1 of the Local Health Administration Law, 16

P.S. §12005.1, any county which is a member of a Joint-County Department of Health

may withdraw from the department by a majority vote of the governing body; and

WHEREAS, the Board of Commissioners wishes to withdraw from the Lehigh-

Northampton Joint-County Health Department; and

WHEREAS, Section 302(j) of the Home Rule Charter provides that ordinance

approval is required to establish, combine or abolish agencies.

NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF LEHIGH, PENNSYLVANIA, THAT:

1. The foregoing WHEREAS clauses are incorporated herein as if set forth in their entirety.

2. The County of Lehigh hereby withdraws from the Joint-County Department of Health as established in Ordinance 2007- No. 227 and repeals that portion of the ordinance which authorizes the establishment of a single county health department in the event that Northampton County chooses not to participate in a Joint-County Health Department.

3. The proper officers and other personnel of Lehigh County are hereby authorized and empowered to take all such further action, including any necessary transfer of funds, and execute additional documents as they may deem appropriate to carry out the purpose of this Ordinance.

4. The County Executive shall distribute copies of this Ordinance to the proper offices and other personnel of Lehigh County whose further action is required to achieve the purpose of this Ordinance.

5. Any Ordinance or part of any Ordinance conflicting with the provisions of this Ordinance is hereby repealed insofar as the same affects this Ordinance.

6. This Ordinance shall become effective in ten (10) days after enactment.
