REPEALING ORDINANCE NO. 2011-193 REGARDING TERM LIMITS FOR THE COUNTY COMMISSIONERS AND THE COUNTY EXECUTIVE

WHEREAS, by Ordinance No. 2011-193 the Board of Commissioners approved the placement on the November 2012 ballot of a referendum to amend the Home Rule Charter to provide for term limits for certain elected officials; and

WHEREAS, the proposed referendum would impose a limit of three fouryear terms on the office of County Commissioner and increase the number of terms the County Executive may serve from two to three, and would apply to officials currently in office; and

WHEREAS, Ordinance 2011-193 was introduced, considered and passed by the Board entirely after the election of November 2011, by a vote of 6-3 including four "yea" votes by commissioners who knew they would not continue in office after December 2011, and yet the ordinance was written to retroactively encompass commissioners elected in November 2011.

NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF LEHIGH, PENNSYLVANIA, THAT:

- 1. The foregoing Whereas clauses are incorporated herein as if set forth in their entirety.
 - 2. Ordinance No. 2011-193 is hereby repealed.
- 3. The proper officers and other personnel of Lehigh County are hereby authorized and empowered to take all such further action, including any necessary transfers of funds, and execute additional documents as they may deem appropriate to carry out the purpose of this Ordinance.
- 4. The County Executive shall distribute copies of this Ordinance to the proper offices and other personnel of Lehigh County whose further action is required to achieve the purpose of this Ordinance.
- 5. Any Ordinance or part of any Ordinance conflicting with the provisions of this Ordinance is hereby repealed insofar as the same affects this Ordinance.

6. This Ordinance shall become effective in ten (10) days after enactment.
