## COUNTY OF LEHIGH, PENNSYLVANIA RESOLUTION NO. 2016 – 31 SPONSORED BY COMMISSIONER SCHWARE REQUESTED DATE: JUNE 1, 2016

### SUPPORTING THE PASSAGE OF STATE HOUSE BILL 17; AMENDING THE PUBLIC EMPLOYEE PENSION FORFEITURE ACT

WHEREAS, the County of Lehigh requires that public officials and public employees entrusted with carrying out the business of the citizens County maintain the highest of ethical standards and professional conduct; and

WHEREAS, the Lehigh County Board of Commissioners further believes that when the public trust is violated by a government official or employee during the conduct of official business, that official or employee should forfeit his or her taxpayer-funded pension; and

WHEREAS, the Pennsylvania Assembly recently approved House Bill 17 – an action that would close existing loop holes in the Public Employee Pension Forfeiture Act (Act 140 of 1978) that currently allow persons charged with a forfeiture crime to plead to a non-forfeiture crime in order to maintain their pensions; and

WHEREAS, House Bill 17 would also expand the list of felonies requiring forfeiture of the government – subsidized portion of a public pension if an official or employee is found guilty, pleads guilty or no contest to committing in the course of their jobs; and

WHEREAS, a copy of House Bill 17, Printer's No. 3364, is attached to this resolution as Exhibit A.

# NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF LEHIGH COUNTY, PENNSYLVANIA, THAT:

- 1. The Lehigh County Board of Commissioners joins the State House in supporting Bill 17 and encourages Senator Lisa Boscola and Senator Pat Browne to do so in the Senate.
- 2. The proper officers and other personnel of Lehigh County are hereby authorized and empowered to take all such further action, including any necessary transfers of funds, and execute additional documents as they may deem appropriate to carry out the purpose of this Resolution.
- 3. Any resolution or part of resolution conflicting with the provisions of this resolution is hereby repealed insofar as the same affects this resolution.

- 4. A copy of this resolution shall be sent Senator Boscola, Senator Browne, and the County Commissioners Association of Pennsylvania.
- 5. The County Executive shall distribute copies of this resolution to the proper officers and other personnel whose further action is required to achieve the purpose of this resolution.

#### AN ACT

Amending the act of July 8, 1978 (P.L.752, No.140), entitled "An act providing for the forfeiture of the pensions of certain public employees and authorizing the State or political 3 subdivision to garnish the pension benefits of certain public officers and employees upon conviction of certain criminal activity related to their office or position of employment," 6 further providing for definitions, for disqualification and 7 forfeiture of benefits and for restitution for monetary loss; and repealing a retroactivity provision. 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: The definitions of "crimes related to public Section 1. 12 office or public employment" and "public official" or "public employee" in section 2 of the act of July 8, 1978 (P.L.752, 14 No.140), known as the Public Employee Pension Forfeiture Act, 15 amended July 15, 2004 (P.L.733, No.86), are amended and the 16 section is amended by adding a definition DEFINITIONS to read: 17 Section 2. Definitions. 18 The following words and phrases when used in this act shall



have, unless the context clearly indicates otherwise, the

- 2 "Benefits administrator." A retirement board, pension fund
- 3 administrator or employer that manages, controls or maintains a

- 7 In addition to the foregoing specific crimes, the term also
- 8 includes all criminal offenses as set forth in Federal law that
- 9 <u>are:</u>
- 10 <u>(1)</u> substantially the same as the crimes enumerated
- 11 herein[.];
- 12 (2) classified as a felony; or
- 13 (3) punishable by a term of imprisonment exceeding five
- 14 <u>years.</u>
- 15 \* \* \*
- 16 "Public official" or "public employee." Any person who is
- 17 elected or appointed to any public office or employment
- 18 including justices, judges and [justices of the peace]
- 19 magisterial district judges and members of the General Assembly
- 20 or who is acting or who has acted in behalf of the Commonwealth
- 21 or a political subdivision or any agency thereof including but
- 22 not limited to any person who has so acted and is otherwise
- 23 entitled to or is receiving retirement benefits whether that
- 24 person is acting on a permanent or temporary basis and whether
- 25 or not compensated on a full or part-time basis. This term shall
- 26 not include independent contractors nor their employees or
- 27 agents under contract to the Commonwealth or political
- 28 subdivision nor shall it apply to any person performing tasks
- 29 over which the Commonwealth or political subdivision has no
- 30 legal right of control. However, this term shall include all

- 1 persons who are members of any retirement system funded in whole
- 2 or in part by the Commonwealth or any political subdivision. For
- 3 the purposes of this act such persons are deemed to be engaged
- 4 in public employment.
- 5 "SCHOOL EMPLOYEE." AS DEFINED IN 24 PA.C.S. § 8102 (RELATING <--
- 6 TO DEFINITIONS).
- 7 "STUDENT." AN INDIVIDUAL WHO IS:
- 8 (1) INSTRUCTED BY A SCHOOL EMPLOYEE;
- 9 (2) SUPERVISED BY A SCHOOL EMPLOYEE;
- 10 (3) COUNSELED BY A SCHOOL EMPLOYEE; OR
- 11 (4) MENTORED BY A SCHOOL EMPLOYEE.
- 12 Section 2. Sections 3(a), (b) and (d) and 4(a) and (d) of
- 13 the act are amended to read:
- 14 Section 3. Disqualification and forfeiture of benefits.
- 15 (a) Notwithstanding any other provision of law, no public
- 16 official or public employee nor any beneficiary designated by
- 17 such public official or public employee shall be entitled to
- 18 receive any retirement or other benefit or payment of any kind
- 19 except a return of the contribution paid into any pension fund
- 20 without interest, if such public official or public employee is
- 21 [convicted] found guilty of a crime related to public office or
- 22 public employment or pleads guilty or no [defense] contest to
- 23 any crime related to public office or public employment.
- 24 (b) [The benefits shall be forfeited upon entry of a plea of
- 25 guilty or no defense or upon initial conviction and no payment
- 26 or partial payment shall be made during the pendency of an
- 27 appeal. If] The benefits shall be immediately forfeited upon the
- 28 public official's or public employee's entry of a plea of guilty
- 29 or no contest or upon initial entry of a jury verdict or
- 30 judicial order of quilty, with respect to any crimes related to

- I public office or public employment. The forfeiture shall not be
- 2 staved or affected by pendency of an appeal or collateral attack
- 3 on the plea, verdict or order, regardless of whether a court has
- 4 entered or staved the sentence pending the appeal or collateral
- 5 attack. If a plea, verdict or order is vacated and a verdict of
- 6 not guilty is rendered or the indictment or criminal information
- 7 finally dismissed, then the public official or public employee
- 8 shall be reinstated as a member of the pension fund or system
- 9 and shall be entitled to all benefits including those accruing
- 10 during the period of forfeiture if any. Such [conviction or]
- 11 plea, verdict or order shall be deemed to be a breach of a
- 12 public officer's or public employee's contract with his
- 13 employer.
- 14 \* \* \*
- 15 (d) The appropriate [retirement board] benefits
- 16 administrator may retain a member's contributions and interest
- 17 thereon for the purpose of paying any fine imposed upon the
- 18 member of the fund by a court of competent jurisdiction, or for
- 19 the repayment of any funds misappropriated by such member from
- 20 the Commonwealth or any political subdivision.
- 21 \* \* \*
- 22 Section 4. Restitution for monetary loss.
- 23 (a) Whenever any public official or public employee who is a
- 24 member of any pension system funded by public moneys [is
- 25 convicted or pleads guilty or pleads no defense] enters a plea
- 26 of quilty or no contest in any court of record to any crime
- 27 related to a public office or public employment or whenever
- 28 there is initial entry of a jury verdict or judicial order of
- 29 quilty against the public official or public employee in any
- 30 court of record to any crime related to a public office or

- 1 public employment, the court shall order the defendant to make
- 2 complete and full restitution to the Commonwealth or political
- 3 subdivision of any monetary loss incurred as a result of the
- 4 criminal offense.

- 6 (d) [The retirement board, administrator of the pension fund
- 7 or employer of the defendant] Upon the finding of guilty of a
- 8 public official or public employee, or upon the entry of a plea
- 9 of guilty or no contest in any court of record by a public
- 10 official or public employee, the court shall notify the
- 11 appropriate benefits administrator of such finding or entrance
- 12 of plea. The appropriate benefits administrator, upon being
- 13 served with a copy of the court's order, shall pay over all such
- 14 pension benefits, contributions or other benefits to the extent
- 15 necessary to satisfy the order of restitution.

- 20 SECTION 4. THE GENERAL ASSEMBLY FINDS AND DECLARES AS
- 21 FOLLOWS:
- 22 (1) THIS SECTION APPLIES TO THE FOLLOWING PROVISIONS:
- 23 (I) THE EDITORIAL CHANGE IN THE SECOND PARAGRAPH OF
- 24 THE DEFINITION OF "CRIMES RELATED TO PUBLIC OFFICE OR
- 25 PUBLIC EMPLOYMENT" IN SECTION 2 OF THE ACT.
- 26 (II) THE ADDITION OF THE DEFINITIONS OF "SCHOOL
- 27 EMPLOYEE" AND "STUDENT" IN SECTION 2 OF THE ACT.
- 28 (2) THE PROVISIONS REFERRED TO IN PARAGRAPH (1) ARE

- public employment" EXCEPT FOR THE EDITORIAL CHANGE IN THE
- 16 SECOND PARAGRAPH OF THE DEFINITION, and "public official" or
- "public employee" in section 2 of the act.
