Dear Ms. Achenbach:

We have performed certain procedures enumerated below, which were agreed to by you, solely to determine the cash surplus (cash advances less documented expenditures), if any, for contract 16HC0049 (Clearing House staff and related administrative cost), at the Lehigh Conference of Churches (CoC) for the period January through September 2016.

Procedures performed included:

- Verification of cash advances paid by the County of Lehigh to CoC from January 2016 to September 2016 inclusive; and
- Verification of amounts reported by CoC's management to HealthChoices' management as direct and administrative expenses.

This agreed-upon procedures engagement was conducted in accordance with generally accepted government auditing standards and "Government Auditing Standards" as issued by the United States Government Accountability Office (GAO) and "Statements on Standards for Attestation Engagements" as issued by the American Institute for Certified Public Accountants (AICPA). The sufficiency of these procedures is solely the responsibility of the parties specified in this report. Consequently, we make no representation regarding the sufficiency of the procedures performed.

The results of our review:

- Cash advances paid totaled \$412,497.00 for the period January to September 2016; and
- CoC management has \$416,266.86 in contract expenditures for the period January to September 2016.

We were not engaged to and did not conduct a full (financial or compliance) audit, the objective of which would be to express an opinion on the financial statements or performance of the contract scope of services. Accordingly, we do not express such an opinion. Had we performed additional procedures, other matters might have come to our attention that would have been reported to you.

This report is intended solely for the information and use of county human services / HealthChoices management and is not intended to be and should not be used by anyone other than these specified parties. However, this report is a matter of public record and its distribution is not limited.
