III. Provider Forum

• Tisbine Moussa – Northampton County

o IRTF providers have specialized programs for sex offenders and for the ID population – they are: Warwick, KidsPeace and NHS.

• Matt Bauder – Lehigh County

- Approximately 4 5 years ago Magellan partnered with a few residential providers to offer at that time was called short term residential treatment.
 - ✓ Very intensive family work is performed
 - ✓ The program is considered an intensive RTF program
 - ✓ Approximately one year ago providers were asked to develop programs around sex offending and ID services.
 - ✓ All providers updated their program descriptions.
 - ✓ The tracks are a little different than the traditional intensive RTF.
 - ✓ Average length of stay for an IRTF program is 4 months. This is half of what a traditional RTF stay would be.
 - ✓ Average length of stay for sex offending / ID is 6 months.
 - ✓ The team will work with the child at the RTF, the team will also go out to the homes to provide services and very intensive work is performed in order to bring the child back as quickly as possible. Generally, after care will be family based with the IRTF providers following up at least a month afterwards.

VI. Magellan Behavioral Health

Jessica Teel (handout)

- o ICD 10 code is being delayed until October 2015. Any updates will be on our website.
- o Electronic Funds Transfer (EFT): looking to roll this out to some of our counties. No official date at this time or which counties it will effect.
- o Re-enrollment/Revalidation of Medical Assistance (MA) Providers handout all providers need to re-enroll by March 24, 2016 and then every five years after the initial enrollment.
- o BSL/BSC's need to be licensed as of May 26th. This is for Autism services. Will not receive reimbursement unless licensed. Will be updating the contracts with the new codes in the next couple of months.
- Provider focus group will be held on July 30th. Email will be sent out in the next couple of weeks to Providers.
 The focus group is a collaborative for providers who have commercial and Medicaid contracts no real agenda open discussion.
- o D&A Non Hospital section was the only change to the Geo Access Report that is submitted to the counties change is for the positive.

Matt Arthur

- o Carl Kist will be attending moving forward
- o Partners In Care concept is an opportunity for Magellan and providers to connect in a different way than traditionally.
 - ✓ Starting with 10 inpatient providers
 - ✓ The focus will be on acute inpatient
 - ✓ Gives the opportunity to move it from a care manager and a utilization staffmember as the only point of contact for a facility and moves it to a more program focus.
 - ✓ Allows monthly meetings to discuss pros / cons of what is going on in their unit and Magellan and authorizing services.
 - ✓ Moving away from a case discussion to a programmatic discussion
 - ✓ Rolling this out in the next few months
 - ✓ Goal is to decrease the amount of time for the provider utilization review teams
 - ✓ Utilization reviews will occur three times in a 14 day period.
 - ✓ One on one onsite meetings will be held. Review case notes, talk about some of the concerns / barriers.
 - ✓ Group meeting will be held with all providers to discuss best practices.
