  - ✓ New location: 24 S. 5<sup>th</sup> Street (old Veterans Sanctuary location)
- Since closing the Veterans Sanctuary program started Vet Track
  - ✓ Originally funded by a grant from Veterans and Military affairs
  - ✓ Unsure if this will continue after June due to the budget
  - ✓ Veterans status has been upgraded to priority population status
  - ✓ Any veteran can access Vet Track even if not funded by the grant

- o Now have a van for the partial hospital program that will cover the Lehigh Valley
  - ✓ Van will be used to pick up individuals that need transportation

  - ✓ Target Date: August/September 2016
- DDTT (Northwestern Human Services)
  - ✓ Joint decision to continue pilot through 2016
- o Prepping for the P4P (Pay for Performance) for BH/PH

#### Matt Bauder

- Services Councils for Children/Families and Adults have continued
  - ✓ Opportunity to provide feedback on what is working and what is not working, how members access information
  - ✓ Adults meetings will be held at the Goodwill Clubhouse
