- o Ronnie Colbert
  - ✓ Metro bus issue has been resolved
  - ✓ New computers have been installed at Haven House
  - ✓ A traditional Valentine's Day party was held at Haven House
  - ✓ Thrift Shop is doing well. A washer / dryer is available for clients to wash their winter coat
  - ✓ Working with a client outside of the program to make sure all of her medications are working for her
  - ✓ Reached out to individuals outside of the program informing them he is available to talk anytime

#### Children's Advisory Committee – Pat McGarry As reported by Deb Nunes

- o Bulletin came out from OMHSAS related to BHRS providers
  - ✓ Any changes in PROMISE, address change will take 4 6 months for the change to take effect
  - ✓ Billing can be held up for providers until the change takes effect
- IV. Magellan Report Diane Marciano
  - Recovery Celebration will be held on May 1, 2015
    - o 12:00 3:00 at the Iron Pigs
    - Invitations will be sent to providers so they can distribute to members and ask providers to assist the members so they can attend
    - Invitations will be sent to Donna Thorman to distribute to Peer to Peer classes and Board of Directors
    - o Invitations will be going out in early March
  - Hired a Peer Recovery Navigator, Jason Halley
    - Jason will be doing outreach in the community
    - Looking at putting together a Community Advisory Committee
    - Would Jason be interested in talking to the NAMI Peer to Peer class? Donna will advise which class would be best for Jason to present along with the date / time of the class
    - Trained in supervising peers
    - Jason is dedicated to Lehigh / Northampton County

- Hired a Systems Transformation Manager, Tom Walker
  - o Pioneer in the ICM for the Homeless with Conference of Churches
  - o Tom will be dedicated to Lehigh / Northampton County projects
- Dual Diagnosis Treatment Team
  - o Targeting an April launch
  - o One team will be dedicated to Berks, Lehigh and Northampton County
  - o One team will be dedicated to Delaware and Montgomery County
  - These teams are like an ACT team but serves individuals with mental health and intellectual and developmental disabilities
- Continue to work on our integrated care with Haven House (HH) and Neighborhood Health Center of Lehigh Valley (NHCLV)
  - o As of December 31, 2014 provided services to 61 HealthChoices individuals
  - o Continue to collect the outcomes
  - o HH/NHCLV staff assisted 14 individuals in obtaining HealthChoices and linking them to services they need
  - o Haven House hired a certified peer specialist and a nurse

### V. Lehigh County Report – Matt Bauder

- Conducted annual strategic reinvestment planning
  - o Top ranking adult results:
    - 1. Expanded services and options for members with a dual diagnosis (MH/ID and MH/D&A)
    - 2. Adult therapy services for members with an Autism diagnosis
    - 3. Social support services geared toward members with an Autism diagnosis
  - Top ranking child/adolescent results:
    - 1. Expanded service options for members with dual diagnosis (MH/ID and MH/D&A)
    - 2. Basing a providers reimbursement on different quality indicators
    - 3. Increased access to child and adolescent psychiatrists
    - 4. Outpatient satellite programs in schools
  - Moving this to a bi-annual process
    - ✓ First year will be gathering / ranking ideas
    - ✓ Second year will be seeing what ideas can be operational
- Lehigh County issued an RFP in 2014 and Magellan was selected as the County's MCO
  - o Looking at BHRS service to see what can be done to make sure this service is the best service it can be
  - HealthChoices will be putting the CFST results on the HealthChoices website along with links to Magellan's newsletter

### VI. Northampton County Report - Deb Nunes

- Personnel changes
  - Alan Brace retired on 12/30/14 but has been retained to be a consultant for 6 months to train a new accountant. His replacement was hired on 2/16/15 and her name is Sharay Montgomery-Thomas
  - o Kim McCloskey, Clerical Assistant moved to another position in the county
- Reinvestment
  - RFP was sent out for housing Council of Churches is the clearinghouse
    - ✓ Finalize and execute the contract is the final step to completing this process
    - ✓ April is the targeted start date for 38 individuals
  - o Dual Diagnosis Treatment Team
    - ✓ April launch date

- School Based Outpatient
  - ✓ Expanded to the middle / elementary schools
  - ✓ Has been up and running since November 2014
  - ✓ Update will be presented at the next meeting
- o Integrated Care
  - ✓ Continued talks on integrated care for Northampton County
  - ✓ Looking to start in 2015
- HealthChoices workgroup
  - Representatives of all inner divisions of Human Services: Children and Youth, Aging, Mental Health, DP, JPO,
     D&A
  - Work group determines needs of Northampton County
  - o There are lack of services for housing and moving individuals through the services
  - LTSR 8 beds / EAC 6 beds running functionally
- Healthy PA
  - o January 1, 2015 rolled out
  - o Issues continue to occur
  - o Governor Wolf instructed his staff to submit a letter to CMS to withdraw Healthy PA
  - o Governor Wolf moving to Traditional Medicaid Expansion
