I. Review of May 23, 2018 meeting minutes. Meeting Minutes were approved.

#### II. Provider Forum

- NET Services Fred Brown. Change in leadership at NET. Fred Brown is retiring end of August 2018. Ryan Flynn is named as the new Program Director effective Sept 1, 2018. Mr. Flynn has 14 years experience with NET serving as the Clinical Director. The Community Healthcare Alliance thanks Mr. Brown for his many years of dedicated service.
- Lehigh Valley Drug and Alcohol Intake Unit Kristina Ward. Announced the Grand Opening for the newest Recovery Center, August 24<sup>th</sup>. The program is open to anyone seeking recovery support. Location: 1830 Main St Northampton, PA
- Haven Behavioral Hospital Lisa Schwartz. Haven Behavioral Hospital of Eastern Pennsylvania, recently became INN Network with Magellan Behavioral Health. The hospital is expanding, expected to add 19 adult beds by end of year.
- **Pinebrook Family Answers Ann Compostella.** Pinebrook Family Answers is growing. A new outpatient clinic will open located in South Bethlehem, on 4<sup>th</sup> Street. Please contact the program for information on service scope, location, hours, etc.
- St Lukes Amie Allanson-Dunden. The merger of Sacred Heart and Blue Mountain Health Networks to St. Luke's University Health Network will result in planned for changes. With this merger, the community should anticipate additional announcements. Amie announced that there will be a consolidation of inpatient psychiatric hospital beds (Blue Mountain, Sacred Heart, St. Luke's Quakertown, and St. Luke's Bethlehem). This will be accomplished in stages, beginning with beds moving from St. Luke's Bethlehem Campus to St. Luke's Sacred Heart Campus (Fall 2018). All said and done, there will be 174 inpatient beds at St. Luke's at Sacred Heart Campus.
- Salisbury Behavioral Health Cindi Mazza. Salisbury is partnering with Northampton County Pretrial Services as part of a wider reentry project for justice-involved HealthChoices members.

#### II. Member/Family Forum – Ronnie Colbert

- Discussed the continuing need for member advocacy, particularly self-advocacy, in filing complaints with MATP program. Ronnie described issues surrounding scheduling and access to medically necessary transportation which can be solved through communicating needs, and following the process set by LantaVan.
- Matt Bauder offered an update to the meeting with LantaVan, and announced Melissa M. Gemelli of LantaVan will present an overview of LantaVan services, and available supports and guidance at the September 26, 2018 Community Healthcare Alliance meeting.

Bulletin 99-18-10 The purpose of this Medical Assistance (MA) Bulletin is to clarify the Department of Human Services' (DHS) position that any individual or entity approved by the Department of Health (DOH) as a Tobacco Cessation Program (TCP) may enroll in the MA Program to render Tobacco Cessation Counseling (TCC) services to MA beneficiaries.
Bulletin 99-18-09 Reduction of Mailed Paper Remittance Advices. The purpose of this bulletin is to notify all providers that the Department of Human Services (Department) will discontinue the mailing of paper Remittance Advices (RAs) through the United States Postal Service (USPS) to any provider who has elected to receive Electronic Remittance Advices (ERAs), also known as ANSI X12 835 files.

- As a result of DHS policy, Magellan providers must be Promise enrolled. Magellan cannot pay for services rendered by nonenrolled providers. Revalidation is required every five years. If there is a lapse in enrollment, Magellan must stop payment. For revalidation, or for reactivation, or to submit a new application please use the DHS Online enrollment portal. - Important: Please update your agency contacts, specialty services, and website information through Magellan Provider portal for your agency. The best practice is to build a process to review and update your agency profile on a quarterly basis. Magellan uses this information for provider communications, and to provide member information. This is publically searchable.

- ASAM update: The PCPC is targeted to be fully discontinued by December 31, 2108. Training period for ASAM criteria is extended through December 31, 2018. Implementation date is still July 1, 2018. Supervisors are expected to review and sign off on any level of care determinations for staff who have not had the appropriate training.
