I. Review of November 14, 2018 meeting minutes. Meeting Minutes were approved.

#### II. Provider Forum

- New Vitae Wellness and Recovery Bill Leiner. Expanding Traumatic Brain Injury slots; increasing by 50%. Please call or visit the website to make a referral for the <a href="https://www.newvitaewellness.com">https://www.newvitaewellness.com</a>
- Pinebrook Family Answers Ellen Mooney. HIFI Wraparound services are expanding to include Northampton County. Referrals are through children and youth for Northampton County. Children do not need to be involved with child protective services for Lehigh County referrals. HIFI Wraparound may include services such as case management coordination in order to prevent a hospitalization or out of home placement. Integrated behavioral health vans in schools continue to provide services in Bangor, Bethlehem, Allentown, and Easton Schools. Compeer Program is expanding to include children. Leaving jail program completed the first round of classes. Unconditional childcare has been added to the mix. Trauma training is being offered in school districts.
- Kidspeace Outpatient Program Katherine Matonis and Ken Garavaglia. Was licensed by DDAP to provide drug and alcohol services at the 451 Chew St. location (St. Lukes at Sacred Heart Campus). Referrals will be accepted shortly (1-2 months). Information/rack cards were distributed for the walk-in assessments at outpatient locations. The trauma program at Kidspeace Residential programs for complex children's issues are rebranded. The former Trauma Program for females is now named TREE (Trauma, Resilience, Empowerment and Education) and the Sexual Issues Program for males is now named ASPIRE (Adolescent Sexual Preoccupation Intervention Responsibility and Education). Residential referrals are accepted.
- ARCH of Lehigh Valley Ellen Hunt. Expanding the Early Intervention BHRS Program for children with autism ages 2-5 years old. Referrals are accepted now.

#### **III. Advisory Committee Reports**

- Member/Family Forum Ronnie Colbert. Ronnie has been getting feedback from several members concerning the use of injectable antipsychotics. The concern expressed by members is not feeling like a "zombie" on these medications. Ronnie stressed the importance of member self-advocacy in various discussions with doctors, therapists, and family members about alternatives to older and more powerful antipsychotics. Access to shelters was presented. Ronnie shared he made eight referrals to shelters. Matt Bauder presented on recent news that the warming station is expanding hours and attempting to be more flexible during the current seasonal cold snap.
- Children's Bureau No update.
- Provider Advisory Committee Cindi Mazza. Comprehensive Regulatory Reform issues are being tackled by State Representatives these include a package of bills they hope will restructure the state's regulatory environment to spur economic development and job creation. House Bill 209, is legislation sponsored by Rep. Kristin Phillips-Hill (R-York); the bill would establish the Independent Office of the Repealer, which would undertake an ongoing review of existing regulations and be the repository for regulatory recommendations related to repealing existing regulation that stands in the way of growth. Cindi also discussed the work by the State to develop a Universal Screener for Trauma in all PA schools. This dovetails with the local effort to expand OP mental health treatment in school settings.
