# 2020 Budgetary Objectives

- This 2020 budget is **fiscally responsible** and adheres to the Five-Year Fiscal Strategic Plan.
- It maintains our stabilization fund at \$25 Million
- It **prioritizes** the protection and security **of the most vulnerable among us.**
- It makes a significant investment in our infrastructure and ensures a balanced budget.

### Cooperation and Collaboration

- This administration has made every effort to be transparent, accessible and open with the Board of Commissioners.
- We've **invited them to** the budget process.
- We've worked to **remove politics** from the **budget process**.


### Cooperation and Collaboration

- We've utilized the Five-Year Plan requested by the board, and developed by our Chief Financial Officer.
- We've provided **early audit results** and shared **healthcare reports** with the board.
- We've agreed that any **budget surplus** would be placed in the capital fund.

## Ensuring a Balanced Budget

- My administration made \$638,000 in cuts prior to this presentation.
- This required making tough decisions, but necessary decisions. We can't always have everything we want in a budget.
- This balanced budget is crucial to maintaining vital social services and public safety.




# 2020 Healthcare Highlights

 2020 Healthcare Budget reflects a Medical Savings of \$1.5 Million by updates to our Prescription Plan.
 County Active employee annual cost: \$20.2 Million
 County Retirees annual cost: \$9.6 Million
 County annual employee contribution: \$5 Million
 2020 Total Medical \$34.7 Million

\* Only County Retirees start day before January 1, 1987
\* The 2020 employee contribution will not change.




#### Employee Healthcare Payroll Deductions



### Pension Plan

- 2020 Budget contributes **\$15** million to Employee Retirement Plan.

# 2020 Budget Highlights

 Based on the median Lehigh County Property assessed at \$201,000 the proposed 2020 Lehigh County Property Tax at 3.84 Mills would be \$771.84 per year.



- This ensures we stay within Government Finance Officer Association (GFOA) standards.
- It prevents further cuts that would undermine our ability to provide services, promote public safety and serve the people.
- It ensures our bond rating remains stable, saving taxpayers money in the long-run.
- It protects Lehigh County taxpayers from a more painful and severe tax increase.
- It keeps the stabilization fund at \$25 million through 2023.
