- Reported Magellan is looking to coordinate our Spring Member Advisory Work Groups, an opportunity to collect member feedback and is an opportunity to incorporate this feedback into the Quality programming of behavioral health delivery system. Will send more information as plans are made. The current plan is to promote adults and will be hosted in Lehigh County.
- John intends to share trends with provider and member contacts based on his year-end analysis of his role.

(Tom Walker – Strategic)

- Community HealthChoices Community HealthChoices (CHC) is Pennsylvania's Medical Assistance managed care program that includes physical health benefits and long-term services and supports (LTSS). The Office of Long- Term Living (OLTL) in the Department of Human Services oversees the physical health benefits and LTSS of Community HealthChoices. - Governor Tom Wolf announced a focused all-agency effort and anti-stigma campaign, 'Reach Out PA: Your Mental Health Matters,' aimed at expanding resources and the state's comprehensive support of mental health and related health care priorities in Pennsylvania.
- School-based outpatient services Seven providers partnered with local school districts to expand outpatient services colocated in area schools. Forty or so clinics are opening. Tom announced a learning collaborative.

IV. Lehigh County Update – Matt announced the Fall RFP for the Behavioral Health Managed Care Organization resulted in Magellan being named as the BH-MCO partner and confirmed by the Lehigh County Commissioners. The RFP responses included Magellan, Beacon and Community Care.

Matt also shared the success of the Magellan Holiday party for MYLIFE.

Biennial Reinvestment Planning Process – not much feedback on the prioritization of the identified ideas for reinvestment planning. One provider responded to the needs of children and adolescents.

Gaining access to community-based MH counseling, MH crisis hotline for youth and young adults, and Youth Drop-in Center.

Adult service ideas generated three responses. First priority is outpatient walk-in assessments, second priority is a mobile behavioral health team to assist pre/post hospitalization, community based wrap around for adults, a homeless shelter, substance abuse recovery center, crisis residential specializing in IDD.

V. Northampton County Update - Discussed the expansion of Bridge and Housing Subsidies, and Access/Respite program under reinvestment. Kristy also thanked the community for the Lehigh Response to the biennial needs and prioritization process. This feedback will also be taken into consideration for possible reinvestment expansions.
