II. Review of 11/20/24 Meeting Minutes

Minutes were reviewed and approved without corrections.

III. Provider Forum

- KidsPeace is piloting a compliance officer peer networking group with plans to convene next in June.
- Holcomb Behavioral Health Systems assumed NET's outpatient program. Easton is active; Bethlehem pending licensing.

- Treatment Trends plans to expand outpatient services into Slatington and reopen their renovated residential program by summer.
- Haven House added group therapy services, including music therapy and anger management, with a children's art therapy group launching soon.
- Pinebrook Family Answers reported steady Wraparound activity and reminded attendees about the required disabilities training due by July 2025.
- Preventive Measures continues to provide in-home family stabilization services.
- RHA Health Services and HAO Counseling reiterated available outpatient and bilingual supports.
- John Jones (PICs) discussed Medicaid eligibility delays, workforce shortages, and the need for stronger cross-system coordination.

IV. Advisory Committee Reports

a. Member/Family Advisory Committee - Ronnie Colbert

Ronnie shared feedback from Haven House members, praising collaborative staff-client relationships and the launch of creative and therapeutic groups. He encouraged ongoing peer involvement in programming.

b. Provider Advisory Committee - John Jones

John noted the need for integrated care planning and voiced concerns about eligibility disruptions for youth. He welcomed system-level concerns to bring to statewide leadership committees.

c. Children's Advisory Committee - Mike Ramsey

Mike emphasized proactive supports for transition-age youth and underscored the value of youth and family voice in planning efforts.

V. Magellan Behavioral Health Report

a. Patty Marth - Compliance

Recent email blasts covered:

- Telehealth documentation requirements
- Peer Support Services guidance
- Updates to Psychiatric Rehabilitation regulations (55 Pa. Code Chapter 5230)

• Language access requirements under MA policy

b. Mike Ditty – Network

Providers were reminded to keep credentialing and administrative contact information up to date.

c. John Lees - Member and Family Advocate

Recruitment is ongoing for Complaint and Grievance Panel members, especially those with SUD or autism experience. Participants receive \$100 per hearing. The Behavioral Health Matters podcast will feature Dr. Caroline Carney on behavioral health and stigma reduction.

d. Janet Verga – Recovery and Resiliency (via Tom Walker)

Peer Support Network meetings resumed. Next session: April 9 at Haven House. Updates on Psychiatric Rehabilitation were shared. Age 14 approvals require prior authorization. Northampton County continues supporting CPS trainings.

e. Tom Walker - Strategic

New program approvals are paused due to Commonwealth rate constraints. Magellan continues to log Interested Provider Forms and assess network needs.

VI. Northampton County: Updates / Reinvestment / Issues Presenter: Kristy Cole

- High-Fidelity Wraparound: 17 active, 9 pending; steady engagement.
- Concern Respite: 7 members served.
- Restoration LTSR (COMHAR): Full occupancy. Funding transitioned from reinvestment to Magellan capitation.

- Safe Harbor Expansion: Awaiting construction start.
- CAMS Care Rollout: RFI announcement set for April 17 symposium. Education Day TBD. Multi-year plan includes 200 clinicians over 4 years.

VII. Lehigh County: Updates / Reinvestment / Issues

Presenter: Matt Bauder

- 2:1 ABA Reinvestment: One member actively served; new referral anticipated by summer.
- High-Fidelity Wraparound: 17 active, 2 pending.
- CBCM Housing (Conference of Churches): 79 individuals received short-term rental assistance.
- SDoH Fund: 39 members supported with transportation, food, and other needs.
 Daycare underutilized.
- DUOS: Rapidly scaled to 70 members. Provides flexible supports for seniors.
- Concern Respite: 6 members served; 5 used kinship providers.
- Mary McGonigle added that Integrated Services assisted 50 families and conducted systems coordination for 20.
