III. Provider Forum

Haven House announced an upcoming **Art Show and Open House** at their facility on **May 30, 2025**. They currently have **openings for outpatient counseling and medication management** services. Additionally, they are offering **two Anger Management classes**, which are accepting new participants.

Bethlehem Health Bureau shared outcomes from a recent **CARE** (**Coordinating Assistance Resources Event**) aimed at engaging individuals experiencing homelessness.

KidsPeace reported **openings or a short wait list** for **mental health outpatient services**, including **therapy** and **medication management**.

The agency recently **hosted a liaison meeting**, originally focused on psychiatric hospital utilization trends, which has now expanded to include discussions around **customer relations**, **hospitality**, and **referral engagement** to support census-building efforts.

IV. Advisory Committee Reports

a. Member/Family Advisory Committee - Ronnie Colbert

c. Children's Advisory Committee - Mike Ramsey

Liability insurance premiums are rising significantly due to increases in jury awards and settlements. Agencies should anticipate and budget for these increases accordingly.

School bus safety enforcement has increased. Buses are now equipped with external cameras to monitor whether vehicles stop as required. Staff are encouraged to be reminded and to reinforce with clients and families the importance of observing these rules.

As a follow-up to the OMHSAS Psychiatric Residential Treatment Facility (PRTF) Regulatory Forum held on May 21, 2025, a presentation <u>slide deck</u> has been made available for providers and stakeholders to review.

OMHSAS Bulletins:

 OMHSAS Peer Support Services Bulletin Update: The Office of Mental Health and Substance Abuse Services (OMHSAS) updated the Peer Support Services (PSS) Bulletin and Provider Handbook, issued as OMHSAS-24-05 (effective December 20, 2024). An accompanying Peer Support Services Frequently Asked Questions document is available to providers (posted on the Department of Human Services website) to assist with implementing the updated guidance.  FQHC/RHC Billing Guidance: The Pennsylvania Department of Human Services, Office of Medical Assistance Programs (OMAP) has issued a new bulletin advising Federally Qualified Health Centers (FQHCs) and Rural Health Clinics (RHCs) on the appropriate procedure codes, modifiers, and places of service for billing Medical Assistance (MA) covered services. This guidance applies to FQHC/RHC providers in the Fee-for-Service system; those in managed care were advised to contact the relevant managed care organization for any billing or coding questions.

- Medical Assistance (MA) Bulletin #99-25-02 Behavioral Health Fee Schedule Changes: Medical Assistance Bulletin #99-25-02 outlines revisions to the MA fee schedule, with several changes specific to behavioral health services effective May 1, 2025. Key changes include:
 - Place of Service (POS) 10 Telehealth Provided in the Patient's Home is now an allowed setting for procedure code 90853 (group psychotherapy) for provider type 08, specialty 110 (Psychiatric Outpatient clinics).
 - Procedure code 99452 (Interprofessional consultation) is now opened for provider type 08, specialty 184 (Outpatient Drug & Alcohol clinics).
- OMHSAS Bulletin Series Update: OMHSAS announced Bulletin Series Update OMHSAS-25-01 (effective May 14, 2025), which provides an updated list of obsoleted OMHSAS bulletins. Providers were advised that the bulletins listed in this update are no longer in effect and should no longer be referenced for guidance going forward.

b. John Lees reporting for Mike Ditty – Network

c. John Lees - Member and Family Advocate

- The Magellan Member Advisory Workgroup will meet on July 17, 2025, at 12:00 PM, hosted at NAMI Lehigh Valley. Transportation stipends are available for attendees. John encouraged providers to promote participation among their members and families.
- John highlighted the <u>Behavioral Health Matters Podcast</u>, noting Episode 11 (focused on suicide prevention with special guest Jim Presto (AFSP Lehigh Valley Chapter – Co-Chair; Aevidum Lehigh Valley Chapter President; and suicide loss survivor) will release next week.

d. Recovery and Resiliency - Janet Verga

Janet will share information on the upcoming Peer Support Coalition meetings by email.

e. Strategic - Tom Walker

Tom presented the current Request for Information (RFI) opportunity for CAMS Care training, due June 30, and shared details about the upcoming Education Day scheduled for June 2 at Colonial Academy.

Tom also addressed concerns about flat or declining enrollments in the HealthChoices program. He noted that he will circulate information from the County Assistance Office (CAO) to support both member and staff training efforts. Providers were reminded to use the materials previously distributed by Magellan regarding Medicaid enrollment renewal dates and to regularly check members' eligibility status.

If a member disagrees with a CAO determination, there is an escalation process available. Providers are encouraged to advocate for members and escalate cases when eligibility decisions do not align with the family's needs.

Several providers expressed concern about the federal budget and proposed changes to Medicaid funding. Matt Bauder acknowledged these concerns and added that the state budget—due June 30—presents additional challenges. Although.the June.96.deadline.has.passed?negotiations. continue?and.Governor.Shapiro.has.expressed.optimism.about.reaching.an.agreement.soon; The proposed state budget includes significant investments in education, workforce development, and economic development, while also addressing a structural deficit and potential impacts of federal spending cuts.

Providers were encouraged to contact their state representatives to gain a clearer understanding of the budgetary landscape and to advocate for maintaining Medicaid funding.

VI. Lehigh County: Updates / Reinvestment / Issues Presenter: Matt Bauder

- 2:1 ABA Reinvestment (ABA Support Services): One member actively served; seeking a new referral.
- High-Fidelity Wraparound (Pinebrook): 22 members served in April.
- CBCM Housing (Conference of Churches): 110 individuals received short-term rental assistance.
- SDoH Fund (Conference of Churches): 41members supported with transportation, food, and other needs. Daycare underutilized.
- DUOS: For ages 65+ focused on transportation and food vouchers. 87 members received services through the SDoH funding. Provides flexible supports for seniors.
- Concern Respite: 11 members served in April. 7 families served in Kinship model.
- Drew promoted the need for grievance and complaints panel members. Must be receiving services or a parent/guardian of a HealthChoices Magellan member. We are seeing an increase in substance use disorder grievances, and especially in need of individuals with lived experience in those treatment domains.
- Drew shared the next PIP (Population Improvement Program) is on assessment of suicidality and suicide prevention. Providers can expect to receive additional information from Magellan about the PIP.

VII. Northampton County: Updates / Reinvestment / Issues Presenter: Kristy Cole

High-Fidelity Wraparound (Pinebrook): Seven served in April with one on the waiting list.

- Concern Respite: 9 members served. Kinship care is being used. Group services are also being provided.
- Restoration LTSR (COMHAR): Full occupancy. Funding transitioned from reinvestment to Magellan capitation.
- Safe Harbor Expansion: Awaiting construction start.
- SDoH and Housing Plan (Conference of Churches): SDoH plan is up at the end of this year, and it is not yet determined whether the program will continue, and if it is possible to expand the plan for seniors, such as what Lehigh is doing with DUOS program.
- CAMS Care Rollout: RFI announcement set for April 17 symposium. Education Day TBD.
 Multi-year plan includes 200 clinicians over 4 years.
