ORDINANCE NO. 2018 – 664

**AN ORDINANCE FIXING SALARIES, BONDS AND DUTIES OF BOROUGH OFFICIALS, APPOINTEES AND EMPLOYEES FOR
THE FISCAL YEAR JANUARY 1 – DECEMBER 31, 2019**

WHEREAS, the Council of the Borough of Coopersburg, as part of its proposed budget for fiscal year January 1 – December 31, 2019 determined the wages and salaries to be paid to its employees and appointees; and

WHEREAS, notice of the proposed adoption of this Ordinance was duly published;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Coopersburg:

SECTION I

Healthcare and Pension withholding:


Public Works Department:	\$0 towards healthcare costs & \$550 reimbursement for health expenses

ENACTED AND ORDAINED by the Council of the Borough of Coopersburg on November 20, 2018.


