NOTICE TO EMPLOYEES IN CASE OF WORK-RELATED INJURIES

If you suffer a work-related injury, immediately report the injury to your supervisor and complete the Workers' Compensation Incident Report located on the County Intranet. Failure to do so may delay your benefits or may cause you to lose your rights to benefits paid by your employer for necessary medical treatment and supplies.

- All treatment must be obtained from one of the healthcare providers listed below.
- You must continue to visit one of the healthcare providers listed below if you need treatment for 90 days from the date of your first visit.
- After this 90-day period, if you still need treatment, you may go to another healthcare provider for treatment as long as you notify Sphere Risk Partners or your Human Resources Workers' Compensation contact within five (5) days of your visit to a new provider.
- If you are faced with a medical emergency, you may secure initial emergency treatment from any hospital emergency room. However, after the initial hospital emergency room visit, follow-up treatment must be obtained from one of the following healthcare providers.

<u>NOTE</u>: EMERGICENTERS/URGENT CARE CENTERS ARE NOT HOSPITAL EMERGENCY ROOMS AND ANY TREATMENT COSTS INCURRED AT THESE FACILITIES WILL **NOT** BE COVERED.
