VII. Northampton County: Updates / Issues

- Northampton County received approval on June 28, 2017 from the state to proceed with re-investment project of 2:1 staffing
- Still working out contracts and measured outcomes
- End of August is the target launch date
- Small Program that will be for kids for up to 6 months of service who are coming out of RTF or inpatient who have been aggressive and have team work with them including overnight stays
- Project to last for 2 years

- Courtesy Letters for Timeliness in filing were sent out approximately 200 providers.
- Receiving feedback on letters and a desire to find out why and try and stop it from happening again
- State meeting to take place in Harrisburg on Thursday, July 27, 2017 follow up from that will be discussed at the next meeting in September.

VIII. Lehigh County

- **Matt Bauder**

- Reinvestment planning ideas that were received have been prioritized and are beginning to work on implementing them
- Liz will present in September on the reinvestment priorities that will be worked on in the next year
- 2:1 project will be implemented; approval given from State on July 20, 2017; Lehigh's contract with ABA Support Services will be executed for January 1, 2018
- This is a highly specialized program and referrals will come directly from either Lehigh and Northampton HealthChoices and/or Magellan
- Haven house has partnered with a physical health partner more to come on with whom
- The physical health partner will be leasing the other side of the Haven House building and will be a PCP with approximately 2 RNs
- Goal will be to ensure members Behavioral health and physical health can be met as efficiently and as easily as possible
- OMHSAS- BH SPECIALST LICENSING application process for BHS providers has changed – please see attached
- Effort to stream line the process for licensure
- A Secretary has been chosen for the integration of the Department of Health Aging, Human Services and Drug and Alcohol more information to come on this
- No updates on the Selected PHMCOS since winter/spring
- Appeals process is still ongoing
