### **Farmers Market Nutrition Vouchers Available by Mail**

Lehigh County Office of Aging and Adult Service employees will distribute Farmers Market Nutrition Program vouchers to eligible senior citizens through mail while supplies last. The vouchers are available to Lehigh County residents 60 years or older whose total gross household income is within the income guidelines: \$23,606 for a one-person household and \$31,894 for a two-person household. To qualify you must be 60 or older (or turn 60 by 12/31/20) and meet the household income quidelines.

A one-person household is eligible to receive four \$6 vouchers and a two-person household eight \$6 vouchers **one time only**. A list of local farmers markets where the vouchers may be used to purchase fresh fruits and vegetables can

be found at <a href="www.pafmnp.org">www.pafmnp.org</a>. This program does not include seniors who are living in nursing home facilities, convents, or residential facilities where meals are provided. The vouchers will not be accepted at grocery stores and must be used by November 30, 2020.

Farmers Market Vouchers will be mailed this year. You may complete the application form that is located on the agency website at <a href="https://www.lehighcouny.org">www.lehighcouny.org</a> on the Aging and Adult Services page and email or mail it to the office. You may also email

agingandadult@lehighcounty.org for an application or call 610-782-3200 to request an application be mailed to you.

### **Lehigh County's Unsung Hero Event Rescheduled**

Every May, the Administration for Community Living (ACL) leads our nation's observance of Older Americans Month. Because of COVID-19 this year's event has been rescheduled.

### Lehigh County works to reduce social isolation during COVID-19

Lehigh County Aging and Adult Services began a friendly phone call program in April for elderly individuals struggling with loneliness and social isolation during the COVID-19 crisis. It provided social support consultations and information on resources. The case worker was consistent throughout the weeks maintaining a steady relationship with the individual and understanding their current situation. About 45 older adults have asked to receive phone calls and the case worker makes about 20 calls per day.

"I spoke to R.B., wife of consumer, for about an hour. She expressed how frustrated and lonely she's felt being the sole caregiver of her husband with de-

mentia. She said all she really needed was to have a conversation with someone. She thanked me and said she looked forward to the next time I called."

"S.L. was a consumer whose fridge broke down. I gave her a call the same day and spoke to her for over an hour. She explained her worry about COVID -19 and the fear to step outside her house. She told me she had no family in the area and no one who could go and get groceries for her, We signed her up for home delivered

meals and provided shelfstable meals the following day. She was very happy and grateful and agreed to receive weekly calls looking forward to have someone to speak to each week."

"I spoke to S.C. today. She lost her husband about a month ago and said she looked forward to our calls. We spoke for over an hour and I believe our calls make her feel a bit more hopeful."

### **Agency Delivers Extra Meals During the Pandemic**

Lehigh County Aging and Adult Services was able to deliver COVID meals to any consumer who expressed a need. These extra meals allowed Lehigh County seniors to stay home and reduce their risk of COVID-19 by not having to go out for food. Many of these meals were delivered by Senior Center staff and agency staff.

In addition to these meals, the agency was able to purchase additional meals from Meals on Wheels allowing current consumers to receive two meals a day reducing the need to go out to the store. 20,913 COVID meals were delivered during this time.
