
# WELCOME TO THE LEHIGH COUNTY DEPARTMENT OF CORRECTIONS



## 1817- First County Prison was constructed at the 4<sup>th</sup> and Linden street site



1986- A Federal lawsuit was filed by inmates citing overcrowded conditions and therefore, unconstitutional conditions


1988-Under pressure of a Federal Judge, Lehigh County agreed to start working on plans for a new prison

Early 1989- The Judge ruled the maximum inmate population at Lehigh County Prison was to be 242. For each inmate over that number, Lehigh County would be fined \$100 per day.

Late 1989- Rather than release prisoners, a makeshift temporary prison facility was opened at our Salisbury site to take the overflow until a new prison construction was completed.

1992- Opened First phase of the new prison

1994- Opened Second and final phase



The Jail is a state of the art 250,000 square foot, Direct Supervision high-rise facility. Corrections Officers work inside the housing units where they have direct contact and interaction with inmates. The maximum-security facility houses pre-trial detainees as well as those serving local terms of sentence.

The facility has a maximum capacity of 1,363 beds, however we operate at a capacity of 1,267 beds.

Renovated in 2011, our Community Corrections Center is a 400-bed facility which provides a cost effective alternative to a secure environment. This led to the closure of the women's facility on 6th street and the ladies were transferred to the new facility.





This facility affords sentenced individuals varied prescriptive rehabilitative programs, as well as the opportunity to enter the community for work, perform community service work, and for other pro-social activities under structured parameters.

**Our Juvenile Detention Center** closed it's doors in early 2014 and since then we have contracted with other counties to house our juvenile offenders at a per diem rate.

Imagine yourself.....

You are arrested, processed into the jail and placed in a housing unit. You are in a 2 person cell that is about 6' X 10'. You are secured in that cell about 18 hours a day.



There are concrete floors, block walls, steel doors, steel tables and plastic chairs. There is a TV in the dayroom for up to 48 inmates to watch at any one time.

You can purchase your own TV and pay for your own cable.

You can purchase commissary items much like you can go to any convenience store and pick up snack food items and hygiene articles (in addition to what is provided).

What happens if you do not comply with the rules and regulations?

- Misconduct Process
- Disciplinary Segregation
- Behavior Modification

We are a "no frills" operation. We are cognizant of our costs and our responsibility to the tax payer to contain those costs. That is the reason behind some of the revenues we receive and the various costs for the inmates.

Lehigh County Prison formally changed it's name to Lehigh County Jail in 2014.

Our health care services are contracted with an outside vendor who is Prime Care Medical Inc. We have medical coverage 24/7. Medical staffing includes licensed mental health staff, Psychiatrist, MH Nurse Practioner, Physician, Physician Assistants, RNs, LPNs and Medical Assistants.

In a year's time, there were 6,087 Physician/PA visits, 3,168 sick visits with a nurse, and 2,073 inmate contacts with a Psychiatrist

Inmates receive healthcare as required by law. However, they are responsible for a "co-pay" to see the nurse and doctor just as you and I are. If you do not have money on your account, you will be seen and treated regardless.

In 2020, there was a total of 813,600 meals served at the jail; 47,225 meals served at the Community Corrections Center for a grand total of 860,825 meals served.

More meals served than the busiest restaurant in the Lehigh Valley

The meals are prepared by inmates and kitchen supervisory staff. The menu is a four-week rotating menu, approved by a dietician, and includes medically necessary diets and those for religious reasons.



On March 13th, 2020, we closed our doors to visitors and volunteers due to the COVID-19 Worldwide Pandemic. Our Pandemic Response Plan was initiated, revised, and adjusted based upon the changing and evolving recommendations made by the CDC, the PA Department of Health and our contracted Healthcare Provider.

In a "normal" year, we offer a large variety of programming at both the jail and the community corrections center. Inmates can stay active and busy throughout the day by participating in the programs.

Our case managers meet with inmates and develop a program agreement for the inmate. The programs suggested for participation are based upon a treatment screening questionnaire, family dynamics, history of drug or alcohol use, educational background, current charges and other factors.

We are fortunate to have over 250 volunteers from the community come into the facilities and provide programming. These programs vary from educational, addiction and faith-based support.

On a typical Sunday, we have a variety of faith-based programs that span from 8 in the morning until 10 at night for those that wish to attend.

Many of those same volunteers also hold services and programs throughout the week for inmates as well.

Every day, between the hours of 8:30 a.m. and 10 p.m., an inmate can participate in educational and treatment programs.

# Recovery in Progress Program

This program is a Drug and Alcohol based therapeutic community. The program utilizes multiple disciplines such as 12 step treatment, group based methods and individual treatment.

Residents work on better decisionmaking, life skills, and personal accountability in addition to their drug and alcohol therapy.

The all encompassing treatment dynamic is used in hopes of returning the resident into the community with tools to remain drug and alcohol free!!

### **Community Corrections Center**

Inmates can be transferred to the CCC via several different paths. They can be a direct commit from court. Their sentence can include transfer to the center, they can petition their sentencing Judge themselves, or they can also go through the jail's referral process.

## **Community Corrections Center**

A resident is sent to an agency in the community to pick out clothing for interviews. Staff then conduct a panel interview for practice and provide tips and guidance for a successful interview. The resident is then provided a 10-ride bus pass for their completion.
