PRIOR TO CIRCULATION

- Top of the Petition must be completed before obtaining signatures.
- Electoral District must include municipality and ward and/or district and length of term (2 years for Republican)
- Candidate must be a qualified Elector (voter) of the district and a member of your Party.
- Candidate's name exactly as it is to appear on the ballot.
- No nickname unless it is a derivative of legal given name no titles such as Dr., Mr., Mrs., etc.

SIGNERS

- Minimum of ten (10) signatures. More than the minimum is recommended.
- Each signer may sign petitions for as many candidates for each office as they are permitted to vote, and no more.
- Signer must be a qualified Elector registered and enrolled in your Party in the election district noted on petition.
- Each signer must personally insert all of their own information Signature, Printed Name, House Number, Street or Road, City, Borough or Township, and Date of Signing. Given names must be used: no nicknames or titles.
- Ditto marks are not permitted.

AFFIDAVITS ON REVERSE SIDE OF PETITION

- Statement of Circulator: must be completed <u>AFTER</u> obtaining all required signatures.
- Candidate's Affidavit may be signed and notarized within the JANUARY 28 FEBRUARY 18 petition filing period.
- All notarizations <u>MUST</u> include the Notary's signature and **official inked stamp** indicating municipality and expiration date of commission.
