The only other employees are seasonal positions (Summer Rec staff, Visitor Center, etc.) with no-one person making more than \$3,000 annually. Northern Lehigh Recreation also has various program and fitness instructors who are hired as 'contracted services' and are not officially Northern Lehigh Recreation Authority Employees.
