- \$44.00 for Certified Mail
- \$52.00 for Registered Mail (Outside of the U.S. Only)

*Make checks payable to the Lehigh County Sheriff's Office*

***\*Pro-se litigants – Cash or money order (NO PERSONAL CHECKS)\****

**Requirements for service:**

1. [Order for Service](#) form needs to be **completely** filled out. (We do not accept P.O. Box or R.D. numbers)
2. Self-addressed stamped envelope to your office- **Per case.**
3. Advance fee needs to be paid.
4. **Deputization Fee: \$49.00** in addition to the document service fee
5. or **Allegheny, Delaware, Lancaster, Monroe, and Westmoreland** Counties, you need to complete their own Order for Service Form in addition to Lehigh County's Order for Service Form.
